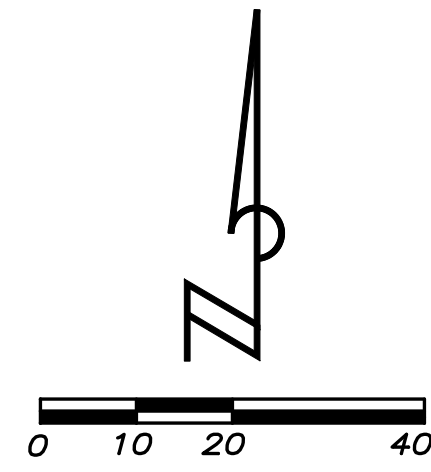
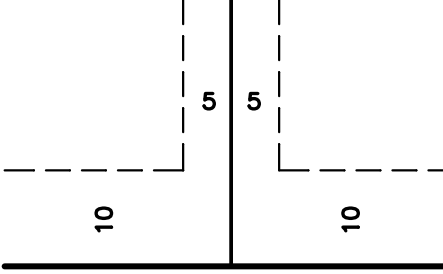


DENTAL OFFICE ADDITION

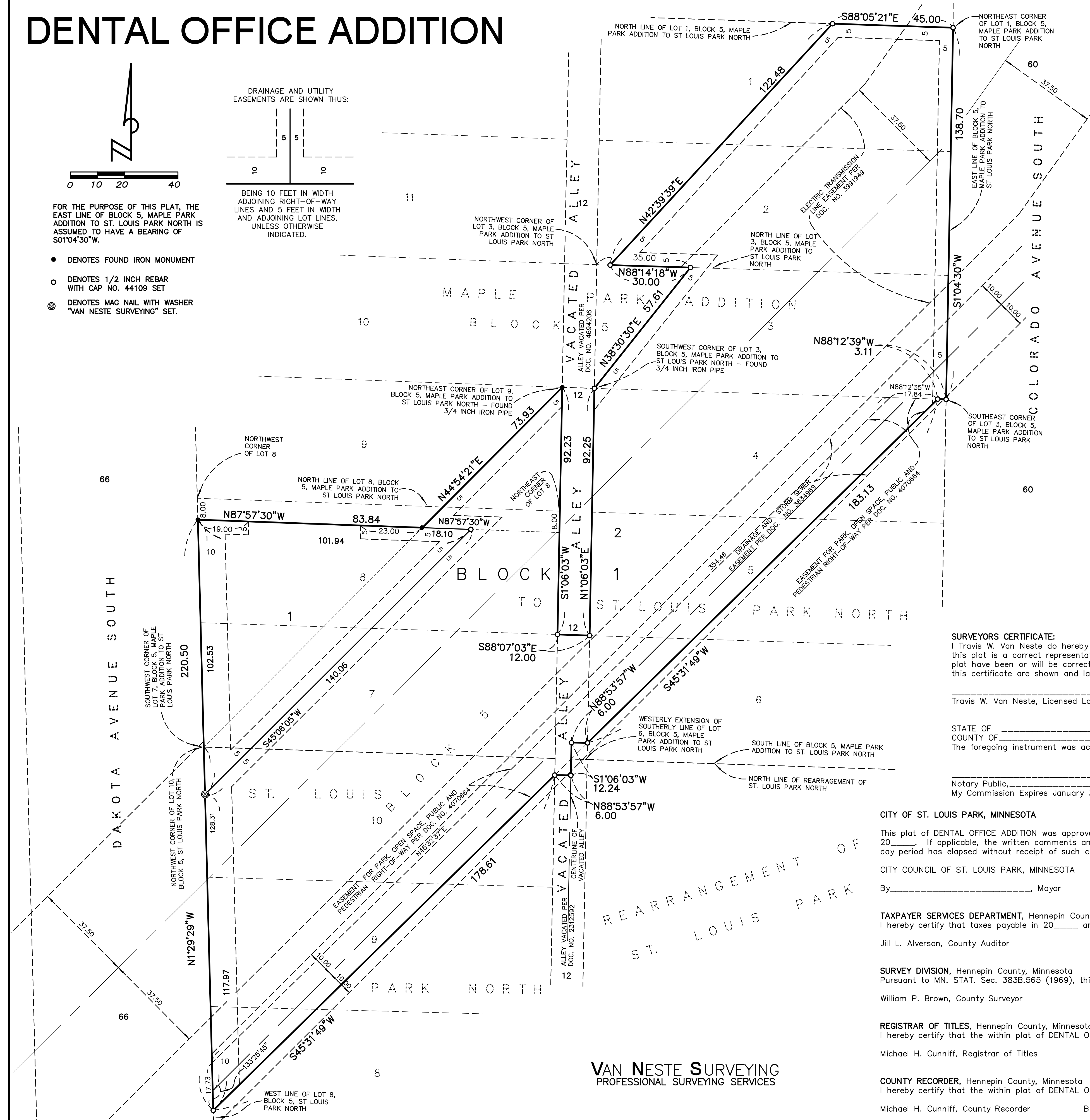
